# THE UNIVERSITY OF TENNESSEE AT CHATTANOOGA Study Abroad Program

1.	All THE UNIVERSITY OF TENNESSEE AT CHATTANOOGA Study Abroad program participants must conduct themselves in a manner that shows respect and consideration for their host country. Any member of a Study Abroad program whose behavior is deemed detrimental to the functioning of the program or offensive to the host culture will be subject to dismissal. Disruptive conduct or inappropriate sexual behavior similarly merits dismissal (initial)
2.	Students in this program must maintain the same standard of the student code of conduct and academic work as would be required by THE UNIVERSITY OF TENNESSEE AT CHATTANOOGA campus. Students are responsible for arriving on time for classes, required meetings, cultural excursions, and for following the program schedule set forth by THE UNIVERSITY OF TENNESSEE AT CHATTANOOGA program coordinator or accompanying instructor (initial)
3.	THE UNIVERSITY OF TENNESSEE AT CHATTANOOGA Study Abroad program students agree to show courtesy and respect to their fellow group members, their instructors, and host institution. Students will not disrupt others who are sharing housing accommodations during the program (initial)
